On behalf of the Board of Directors, staff and volunteers, we would like to thank you for your support of West Suburban Humane Society in 2019. This year we celebrated 47 years of helping animals in need.

A few of the program highlights from this past year include:

- In 2019 we adopted out 562 dogs and cats. Several of these animals needed life saving medical treatment which we were able to provide through the generosity of our supporters.
- We had over 544 dedicated volunteers providing 39,003 hours of service to the shelter, through cleaning animal areas, facilitating adoptions, transporting, socializing, fostering and working special events. We couldn't survive without our wonderful volunteers.
- In 2019, a long-time dream was realized when we broke ground on a new 8,600 square foot adoption center. Some exciting features of the new adoption center include:
 - More areas for animals to roam and play and be isolated medically when necessary.
 - The design will allow for improved traffic flow and enable us to service more animals and families per year.
 - An ergonomic layout and use of natural light will greatly reduce stress for animals awaiting adoption.
 - Our new Humane Education Room will allow us to offer more teenage and youth summer camps and humane education programs to benefit the local community.

This is an exciting time at West Suburban Humane Society! We would like to extend a heartfelt thank you to all of our generous supporters who contributed to our work in 2019. Every dollar is important and without your help, we would not be able to further our mission of helping homeless animals. Your donation can and does save lives!

West Suburban Humane Society (WSHS) is a volunteer-based, animal welfare organization that was founded in 1972 as a lost and found referral service.

We provide housing for up to 25 dogs and 60 cats at a time. We operate at full capacity at all times with animal care and adoptions being provided by 3 full-time and 9 part-time employees and nearly 500 volunteers. Our facility is open to the public 6 days a week.

Mission

WSHS is dedicated to operating a premier animal shelter for the purpose of finding safe, permanent and compatible homes to adopt domestic dogs and cats. We are committed to educating and encouraging the public to humanely care for dogs and cats.

Vision

WSHS will achieve and sustain its reputation for being the premier humane organization in Illinois. To achieve such recognition, WSHS will focus on the following critical components:

Advocacy: WSHS will promote the humane care of dogs and cats by working with government agencies and other agencies to promote the humane care of animals.

Care: WSHS will be the preeminent provider of animal care, working with high quality veterinarians to provide the most appropriate medical treatment for non-terminal conditions of cats and dogs in our care. Further, WSHS will develop innovative practices, such as working with reputable trainers in the area, to ensure that every animal in our care receives the best total care before being adopted by the most compatible owner.

Education: WSHS will educate our staff, volunteers and members of the community on proper pet health care and safety. We will provide ample information and constant support to our adoptive families and act as an invaluable resource for educating the public at large.

Fundraising: WSHS will remain financially solvent and transparent so that we can continue to focus on finding new sources of revenue and maintaining our relationship with those who have provided financial contributions.

Values: We believe in the following core values:

- Serving as a resource to educate the community and animal owners about responsible dog and cat care.
- Providing high quality medical treatment for animals in our care.
- Controlling the pet population through spay and neuter.
- To always act ethically and in the best interests of both animals and potential adopters.

- Working as a team to develop creative solutions for potential adopters and achieve the best results.

He showed up on the doorstep of a Good Samaritan and begged to be let in out of the cold. The family took him in and kept him for a week while they posted flyers and went door to door looking for his home. Unfortunately, they were not able to locate his owner. They wanted to keep him, but one of their daughters turned out to be allergic, so they contacted the shelter and asked if we could help.

He was so big that we gave him the name Big Tom. Because he was a stray, we had no idea of his age or health, so we had one of our vets do a complete exam, including a blood and urine workup. Tom was estimated to be around ten years old and badly in need of dental. The more troubling news was that during the exam, the vet found a significant heart murmur. Big Tom needed to see a cardiologist about his heart before he could undergo anesthesia for his teeth, so we found him a foster home to wait for his appointment with the cardiologist.

Once he had his echocardiogram, it was determined that Big Tom has hypertrophic cardiomyopathy. Still, without knowing any medical history, it



cannot be determined how quickly the disease will or will not advance. The cardiologist cleared Big Tom for his dental, provided he was on antibiotics for five days before the procedure.

Before we could get the appointment scheduled, Big Tom developed an upper respiratory infection. He was given two weeks of medication, and just when he was well, he began having litter box accidents, so he went back to the vet again.

This time we were dealt a big blow. Big Tom was diagnosed with diabetes. His diet was changed to one good for cats with diabetes, hoping that he would not require insulin. Unfortunately, this was not the case. Big Tom does require insulin and is currently still in the process of getting his glucose levels stabilized. Once he is stable, he can begin the antibiotics and then have his much-needed dental surgery.

As you can imagine, all these treatments are costly, but the shelter never turns its back on an animal in need. WSHS has a proven history of treating and caring for sick and injured animals that many other shelters cannot. These animals have no one except us to advocate for them. With your support, we can continue this mission and help other animals in need that make their way to our doors.

Big Tom's glucose levels have finally stabilized, and he has had his dental. He is living his best life with his long-term foster family. He is a sweet, laid back guy and his foster family adores him. Thanks to our incredible supporters, West Suburban Humane Society can continue to help animals in need.

Sevvy is a little over five years old but originally came to WSHS at nine months of age. She was here a mere 12 days before getting adopted into a loving family. She spent 13 months with them but had to be returned because she was too rough for their aging, slower dog.

At age 2, it took three months for her to find her second home, but they were only able to keep her for six months. One day, Sevvy became possessive over a toy with one of the kids in the home, and after that, they were too nervous about keeping her. She has since had training at the shelter and has no issues with toys with people she knows.

Sevvy was almost 4 when she was returned early in 2017 and has been here ever since. Yes, she needs an adult home as the only pet with a fenced yard, but that's not too much to ask for such a funny, loyal, loving dog! She likes kids, just can't live with them. A few volunteers weighed in on their experiences with Sevvy:

"An insight into Sevvy's fun personality can be seen by counting the number of squeaky toys that are brought in by kennel volunteers just for her! She is so easy to please...a squeaky toy and a tummy rub at the same time!"



"I love all the dogs at the shelter, but Sevvy stands out as my favorite. Before taking her out to the play yards, she always spins in a circle, and that's how you know she's excited and ready to play. For all the times I've taken Sevvy out (which is as much as possible) I've never had any problems with her, and I hope she gets a permanent home soon."

"Sevvy is such a loving dog. I wait for her in the play yard while her training buddy walks her out. As soon as she sees me, she gets so excited she starts to cry and can't wait to run to me and say hello, licking me to death, then falling for a big belly rub."

Finally, a family met Sevvy, fell in love, and made her a part of their family. This is an update we received not long after taking her home:

"Six months ago today, we adopted Sevvy, now named Bailey. She'd been at the shelter for a year and was initially so relieved to have a home, and a bed, and a safe environment. She was quiet and undemanding and so well housebroken – we thought we'd found the perfect dog. Now, six months later, we know we found the perfect dog for us. Bailey is no longer quiet and undemanding – she runs the household with her demands for attention, playtime, and adventures.

Bailey doesn't get walks, she gets adventures. Twice a day, Bailey and my husband get in the car and drive to one of the parks in Downers Grove (we've been to them all). Then we walk, chase geese and ducks and squirrels, and avoid other dogs. Bailey still has aggression problems, but dogs in our neighborhood surround us, and we hope she will eventually "chill out" around them. Until then, we continue to monitor her closely when she's out.

Bailey isn't perfect, but she is a healthy, happy, active, curious, and loving dog. We're so glad she rescued us! By the way, Bailey still loves Pig (we were given six pigs by volunteers at WSHS as we left because it was her favorite toy), but Pig is in a strict competition now with Stick for the favorite toy!"



WSHS is dedicated to operating a premier animal shelter that provides the best treatment for dogs and cats in its care. However, like most everything, quality services come at a price. Due to the shelter's tight budget, many animals would not be able to receive adequate care without significant withdrawal from the organization's operating budget and/ or large increases in adoption fees.

Luckily, WSHS is fortunate enough to have many partners that provide essential services for a fraction of their retail cost. This generosity allows WSHS to continue to care for and place animals into their forever homes at a reasonable fee for adopters and manageable budget for the shelter.

At the West Suburban Humane Society, we never turn our backs on an Annimal in need.

Since our founding in 1972, the shelter has relied completely on the generosity of its donors to provide animal care and shelter for thousands of cats and dogs. The contributions of caring and generous individuals – volunteers, adopters, community members – have empowered us to take in a cat with a broken leg, a dog with a heart condition, and make sure those animals live their lives as a family's loving companion.

Where another shelter would euthanize a cat with heartworm, we make sure she gets the medication she needs. Where another shelter would turn away a litter of puppies with Parvo, we take them in and treat them until they are well. Where another shelter would euthanize a dog or cat that stayed for months, just to make room for another animal, we remain committed to getting that animal a home.

Our needs are as varied as our success stories and as big as the job we do. We're seeking funds to save lives, first and foremost. Veterinary care costs our shelter more than \$80,000 each year, and that's with the generous discounts our partner vets are able to provide. Pet food and animal care, all add up to more than \$200,000 annually.



In addition, WSHS is beginning construction on a new adoption center. Our building is old and was not designed as a shelter, and though we do the best we can with what we have, our mission is to operate a premier adoption center, giving our animals, volunteers and adopters the best experience we can. While we operate on a very tight budget, several generous gifts have provided seed money to begin construction.

Before we could commit to such a large project, however, we needed to ensure all our current needs could be met. Our first responsibility is to our animals, and as we look to the future we must maintain the present. Your gift to the WSHS – whether an annual gift, a monthly donation, a corporate sponsorship or a legacy gift – will save lives right now, and ensures that our mission of caring for homeless dogs and cats continues.

Because of you, we've been able to provide quality animal care for more than 47 years. With your help, we will continue to provide it for at least 40 more.

The Legacy Society is a recognized group of committed WSHS supporters who have chosen to make planned gifts to WSHS. A gift from an estate helps assure continuity of quality services and the future of WSHS. A planned gift signifies the donor's lifetime commitment to WSHS. It allows him/her to make contributions to WSHS which are not 'out-of-pocket' during the donor's lifetime and can be tailored to meet the donor's priorities. Planned giving can help with effective estate tax planning.

Corporate Giving

Corporate gifts are unrestricted and can be directly applied to the pressing needs of the shelter (medical care, building maintenance, etc.). WSHS mission is not controversial and therefore, the majority of people and corporations can agree that WSHS is a worthy cause for their community.
